I.....(the mare's owner/agent) agree to take a nomination to the stallion Corscaron Comet Aur for £400 per pregnancy to be used with the mare

I, Chelsey Babbs (the Stallion owner) agree to the mare named above being inseminated with semen from Corscaron Comet Aur pursuant to all charges being paid, and this contract being completed in full.

The conditions are as follows:

Payment Terms

- Full payment for the nomination fee is due on signing of the contract and no semen will be released/ shipped until full payment has been received.
- If a deposit has been received prior to the start of the breeding season and invoice will be sent for the final amount.
- A 'No foal free return' clause is offered - if the mare loses the foal, or fails to produce a live foal (at 24 hrs old), the mare will be allowed one free return for the following breeding season.
- A 'no live foal produced' certificate from the mare owner's veterinarian will need to be provided to take up the 'no foal free return' clause.
- Should the mare die during the course of the pregnancy, consent of the stallion owner in writing is necessary to transfer the nomination to another mare, along with written confirmation from the mare owner's veterinarian.

Semen collection

- Payment of semen collection is separate to stud fee, and payable when ordering semen collection or shipment.
- Neither the breeding centre nor the stallion owner accept any responsibility for the transport or shipment of the semen, and liability for the costs associated with any losses, or complications with shipment.
- Semen must be ordered at least 24hrs prior to needing to be collected from stallion. Failure to do so means that semen collection and shipment may be unable to proceed.
- If two or more pregnancies are produced from the same mare following embryo transfer additional nomination forms need to be completed for each embryo pregnancy and the nomination fee is due for each.
- As long as all charges are met, and contracts in place, fresh/chilled semen will be shipped as many times as requested.
- Date for close of covering season will be confirmed in July.
- If a collection cannot be fulfilled due to a competition date, frozen semen will be sent at no extra cost.

Contracts

- Nomination contracts are non transferable between mares unless consent is given in writing by the stallion owner prior to semen shipment.
- Neither the stallion owner, nor the breeding centre can be held liable in the event of non-performance, illness or infertility of the stallion, or in the event of extenuating circumstances preventing semen collection occurring.
- No guarantee is offered in the event of a negative result post insemination.
- In the event of the death or injury of the stallion, clauses concerning no foal free return, and transfer of nomination to a different mare become null and void.

Mare Owner Duties

- Notify the stallion owner of the pregnancy status of the mare following each insemination / embryo transfer attempt.
- A veterinary certificate will be required to confirm non-pregnancy and hence transfer of nomination fee to subsequent year.
- Ensure that inseminating veterinarian/technician completes and returns paperwork
- All charges are understood before signing and returning contract
- comply with the HBLB Codes of Practice.
- Warranties: The mare owner warrants that they own the mare detailed in the agreement above, and that they have the right to present her for insemination, as well as the authority to enter into the contract. If the person who signs the contract does not have authority to do so, he or she will be personally liable for all fees, disbursements and other liabilities under this contract.
